Following points were discussed in the meeting:-

PROCEEDINGS

In reference to the earlier meetings held on 19th August 2021 & 8th October 2021, UJS was instructed to submit the DPRs of 38 towns by 30th September 2021, with the first 10 towns DPRs by 31st August 2021, next 10 DPRs by 15th September 2021 and the balance 18 DPRs by 30th September 2021. A detailed summary sheet depicting the population, household data, existing house service connections etc. was to be prepared by UUSDA including prioritization basis of the projects to be taken up.

The status of preparatory works preceding the launch of final policy of AMRUT 2.0, SBM 2.0 and 15th FC was presented by UUSDA. During the meeting the procedure to avail funding was also discussed in detail.

It was discussed that City Water Balance Plan (CWBP) is the key parameter/document to plan and execute the project; therefore all CWBPs should be rechecked/revalidated with the on-site situation/conditions in consultation with line departments. It was directed to revalidate the CWBPs & summary sheet prepared for 93

ULBs for population, house service connections, and gap based on water demand etc. UPJN and UJS will verify the CWBPs and data summarized in the submitted sheet.

The hard copy of CWBPs of 93 ULBs were handed over to concerned line department i.e. UPJN and UJS to recheck and revalidate the same.

It was discussed that, priority of projects should be decided tranche wise for Tranche 1, 2 and 3. Under tranche-1 such projects should be taken up which can be completed in short period of time. Accordingly, the sub projects for Tranche 2 and 3 should also be decided considering the time frame as per policy.

It was directed to UPJN to prepare the list of proposed works and share the DPRs of 38 towns with PMU/UUSDA for checking based on CWBPs and City Action Plan latest by 25th Nov. 2021.

The Government of India has launched three flagship programs i.e.; AMRUT-2.0, SBM-2.0 & XVth Finance Commission dated on 1st Oct'2021. These schemes are performance and target based. Time bound targets has to be achieved and monitoring of the same will be reviewed online by Government of India (GoI). According to guidelines, the required documents have to be submitted to GoI as per timeline.

It was discussed that the services of existing Design Supervision Consultant (TCE in JV with ATHENA already working with UUSDA for ADB project) shall be utilized for the preparatory work of AMRUT-2.0, SBM-2.0 & XVth FC Commission till the time the new PMU on mentioned in guideline is established and approval of the government should be taken for the same.
